The Alliance for Child Protection in Humanitarian Action (the Alliance) held the 2021 Annual Meeting on Child Protection in Humanitarian Action over a virtual platform from the 4th of October 2021 to the 8th of October 2021. The Annual Meeting was an opportunity for Child Protection actors to come together and exchange knowledge and experience, while networking with other agencies, academics, policy makers and donors. This year's theme, Preventing Harm to Children, was selected to explore the lessons learnt, promising practices and innovative approaches to preventing harm to children in humanitarian contexts. The meeting explored primary prevention approaches that address risk and protective that negatively impact children in particular humanitarian settings, alongside examples of prevention programming in emergencies from other sectors. The 2021 Annual Meeting Moments



This year's Annual Meeting on Preventing Harm to Children had the greatest turnout of participants and abstract submissions! It was a great success thanks to all the attendees, presenters, and volunteers. Continuing from our lessons learned from the 2020 Annual Meeting, we were able to engage with Child Protection practitioners and colleagues across the globe over social media. We streamed <u>live on Facebook</u> and kept our Twitter feed up to date with live updates, photos, drawings, and new resources. Below, you will find a summary of Day 1 – Day 5 moments and links to the recordings of the sessions held each day.



The first day of the 2021 Annual Meeting began with the Co-Coordinators of the Alliance, Audrey Bollier and Hani Mansourian welcoming participants and announcing a new record of 94 abstracts that were submitted this year, with over half of them presented during the Annual Meeting. Opening Remarks were presented by Henrietta H. Fore, Executive Director of UNICEF calling all Child Protection practitioners and other sectoral actors to address root causes of harm to children towards sustainable prevention of harm to children. Followed by a Q&A panel on global humanitarianism and prevention, the first set of thematic sessions began. In Thematic Session 1a, "Strengthening Caregiving Environments," presenters discussed various parenting interventions and programming including psychosocial initiatives to reduce child maltreatment. Session 1b centered on "Learning from Across Sectors: GBV, Health, ECD, and Multisectoral Approaches." Presentations were given on how to strengthen multisectoral collaboration to improve child outcomes. Lastly, Session 1c focused on "Preventing Harm to Children Affected by Armed Conflict," where presenters led participants through ways to develop interventions to prevent recruitment and use of children in armed conflict, communicate appropriate negotiations and community-led child protection, and the knowledge needed for prevention.

The second day of the 2021 Annual Meeting started off with the first thematic session of the day, "Preventing Harm to Children in the Context of COVID-19." Presentations covered the needs of various vulnerable groups of children including those who are survivors of sexual abuse and those living on urban streets. The session closed with a case study presentation on providing child psychosocial support in Bangladesh through a helpline. Session 2b, "Preventing Child Marriage," had presentations on various humanitarian programming to address the prevalence and drivers of child marriage, and empowering youth community builders. Session 3a, "Prevention through Multisector Integration: Education and Child Protection," featured context-specific interventions focused on psychosocial interventions to reduce child maltreatment, gender transformative approaches to prevent child protection risks, and behavioral change theory to reduce violence in schools. Session 3c, "Prevention through Psychosocial Support and Life Skills" emphasized the need to build adolescent life skills to cope and build resilience against trauma. Session 4a was entirely held in Spanish, featuring "Experiences from Latin America" on shifting the paradigm within parenting to address child maltreatment. Session 4b, "Prevention of Violence against Children" illustrated the importance of leveraging behavioral and social sciences as well as utilizing community-led approaches to prevent the violence and sexual exploitation of children, women and girls specifically. We closed Day 2 with reflections on the Alliance's fifth anniversary and moving forward, our 2021-2025 strategy, Introducing the Centrality of Children and their

Protection. The Alliance's 4 strategic priorities are 1) accountability to children; 2) localization of child protection; 3) multi-sector and integrated programming and collaboration; 4) and prevention.

Day 3

Day 3 started off with Session 5a, "Strengthening Caregiving Environments," where presenters spoke on the importance of structure household coaching, holistic and targeted family strengthening interventions, and socio-cognitive approaches to prevent child abuse and harm. Afterwards, the L&D Working Group led a session on what participants and their organizations have adapted during COVID-19. This soft opening led to the presentation on the Alliance's 2021-2025 Strategy and its 4 main priorities. We finished the day with a session on Infectious Disease Outbreaks.
