The Scale and Trajectory of Child Protection Funding Cuts

Widespread and Deepening Budget Reductions



Services effectively eliminated in some locations

Not Temporary. Structural.

Funding reductions are now widespread and deepening over time, representing a contraction in child protection in humanitarian action.


Cuts are dismantling critical child protection programmes precisely as needs rise.

Rising Child Protection Violations Since January 2025


Percentage of respondents reporting increase in harms

Child Protection Violations in Conflict Settings

53% of respondents in active conflict settings report **significant increases** in child protection violations since 2025, compared to 26% in other humanitarian settings.

How Organisations Are Adapting to Reduced Child Protection Funding

Percentage of respondents reporting each adaptation strategy

Workforce



- Reduced staff presence or field monitoring visits **53%**
- Reduced quality assurance & safeguarding **15%**

Coverage



- Reduced geographic coverage **55%**
- Reduced number of children reached **55%**
- Prioritising only high-risk cases **38%**

Services



- Suspension or closure of activities **46%**
- Reduced frequency of services **31%**
- Integration into other sectors **38%**
- Shift to remote modalities **15%**

Result: Fewer children in fewer locations receiving fewer services

Shift away from Prevention




Impact of Funding Cuts on Child Protection Staffing

Increased workload for staff




Recruitment freeze



Staff required to cover multiple roles




Increased reliance on junior staff

Impact of Funding Cuts on Community-Based Child Protection

Systemic underinvestment



Community-based child protection structures are:

- ! Facing budget cuts but growing operational reliance
- ! Taking on more responsibility without matching investment

Key Recommendations



Stabilise and Protect Child Protection Financing

- ✓ Avoid disproportionate reductions to child protection funding
- ✓ Ensure prioritisation within resource allocation
- ✓ Provide longer-term, predictable funding cycles



Protect Quality and Technical Capacity as Core Protection Functions

- ✓ Fund supervision, safeguarding & technical advisory functions
- ✓ Invest in adaptive local technical support models
- ✓ Maintain quality assurance & accountability



Support National, Local, and Community-Based Actors

- ✓ Prioritise funding for local & community-based actors
- ✓ Protect community-based child protection approaches
- ✓ Sustain technical support & partnerships



Support Strategic Prioritisation and Adaptation of Services

- ✓ Undertake risk-based prioritisation processes
- ✓ Balance response services & preventive approaches
- ✓ Enhance coordination & information sharing

Coordinated action is required across donors, governments, implementing partners, and coordination bodies to protect critical child protection services
